





REGULATION

GENERAL CONDUCT "GRAND INTERNATIONAL"

- Approved by the MUNYCH Association on July 14, 2025
- **O1. Identification of Participants:** All participants in the GIVMUN Model must maintain their profile photo, which will be sent to them in order to guarantee the security, order, and correct management of the debate.
- **02. Diplomatic Conduct and Protocol:** During all work sessions and activities related to the academic simulation, the Delegates, members of the Secretariat, Teaching Advisors and any other participants must conduct themselves in accordance with **diplomatic protocol**, showing respect, formality and courtesy in their oral, written and body language.
- O3. Prohibition of discriminatory conduct: Discriminatory conduct of any kind based on gender, age, religion, nationality, ethnicity, sexual orientation, physical condition, socioeconomic status, or any other reason will not be tolerated. Any violation of this principle will be punished.







- **04. Communication between delegations:** Direct communication between delegations is strictly prohibited during the formal debate. The only permitted means will be the sending of diplomatic notes addressed to the Board of Directors, which, after reviewing them, may authorize their delivery to the corresponding delegation. The use of private chats or other unauthorized channels will be penalized.
- **05. Presentation and Attire:** To maintain the formality of the event, all participants must wear formal attire (business attire) and present themselves neatly during the virtual sessions. Neutral backgrounds or the official event background are recommended.
- **06. Punctuality and Attendance:** Delegates must arrive punctually to all sessions. If you are expected to be late, please inform the committee. Unexcused absences will directly affect your eligibility for awards.
- **07. Justification for Absence:** All absences must be justified in writing by means of a diplomatic note or through the Advisor or Head Delegate. The Secretariat and the Organizing Committee reserve the right to accept or reject the justification.







08. Remaining in the Session: Delegates may not leave the virtual room without justification. If necessary, they must notify the Bureau by diplomatic note. Unjustified or repeated departures could jeopardize the awarding of recognitions.

09. Use of Devices and Platforms: The use of electronic devices is permitted solely for academic purposes and under the rules established by the Secretariat. The use of filters, visual effects, inappropriate backgrounds, or distracting tools during the debate is strictly prohibited. The use of Artificial Intelligence for the preparation of official documents such as the FPR or RA is prohibited.

10. Conduct that interferes with the development of the event: Any conduct that interrupts the correct development of the simulation will be grounds for sanction.

Serious violations, including disruptions, disrespect, sabotage, or any attempt to manipulate the flow of the debate, will result in immediate expulsion of those responsible, as well as official reprimands from the relevant educational institution.







- **11. Awards and Democracy:** The selection of the recognitions that the MUNYCH Association will grant:
 - Ist Place Best Delegate
 - 2nd Place Outstanding Delegation
 - 3rd Place Honorable Mention

As well as the award and scholarship for the **Best Global Delegate** of the entire event, they will be chosen in three ways:

- Voting of the Board
- Voting of the Delegates
- Logistics team vote
- 12. Authority of the Secretariat: The decisions of the General Secretariat and the Organizing Committee shall be final and binding. Any dispute shall be resolved by these bodies in accordance with these regulations.
